Freedom of expression, on the other hand, is used to indicate not only freedom of verbal speech but any act of seeking, receiving and imparting information or ideas, regardless of the medium used.

Copyright and the Freedom of Expression

When courts have engaged with freedom of expression it is often not in the most direct fashion – especially when disputes arise within the terms of copyright law, as they are likely to be litigated on that basis by experts in that field. The human rights implications typically emerge at a late stage or in subsequent academic writing.

Copyright can engage freedom of expression more subtly. Depending on the scope of copyright and the nature of the remedies against infringers (or in some cases even against non-infringers), when applied to any particular set of facts there are many ways in which copyright can step over the line and disproportionately interfere with Article 10 rights.

Therefore, the freedom of expression has never been undermined under the cover of the Copyright Law. Now, we understand that Article 19 (1) (a) is not unconditional and that one cannot claim to enjoy one's freedom by denying freedom to others. This right is subject to "reasonable restrictions" provided under Article 19 (2) of the Constitution and, therefore, it is crucial to determine the line that demarcates what is covered under the fundamental right to freedom of expression and what ...

Based on this decision, it may be expected that national courts should take more account of a possible conflict between copyright protection and freedom of expression, especially in cases where the infringing copy contributes to a debate of general interest for society (which was not the case in Ashby Donald). National courts should establish a proper and fair balance between the two fundamental rights of freedom of expression on the one hand and the right of property on the other hand.

Does copyright conflict with freedom of expression? First ...

For the first time in a judgment on the merits, the European Court of Human Rights has clarified that a conviction based on copyright law for illegally reproducing or publicly communicating copyright protected material can be regarded as an interference with the right of freedom of expression and information under Article 10 of the European Convention. Such interference must be in accordance with the three conditions enshrined in the second paragraph of Article 10 of the Convention.

The relationship between copyright and freedom of expression has long been debated. Unlike the legal discourse in other jurisdictions, most notably the United States, where it is assumed that free speech and copyright do not collide, in Europe both rights have separate legal effect and are considered to be of equal importance.
