Referenced in the Life Safety Code in Section 9, this widely used national consensus standard is adopted in 30 states, although not Illinois, and is an important component in your suite of sprinkler system requirements.

Since NFPA 25 nor the Florida rules give specifics, it is focused just on NFPA 25 requirements, not potential NFPA 13 issues. NFPA 25 does not require any specific forms or minimum information that is to be included on report forms. This is at the discretion of the contractor or owner. Section 4.4 does reference records that shall be made and maintained. The annex A.4.4.3 references sample forms in Section B.2.
